NGO Training Program

Many NGOs and CBOs face difficulties in scaling up their program and sustaining organizations. Behind these difficulties lie numerous reasons including lack of directional clarity, inability to mobilize volunteers and financial resource, and inability to develop community responsive programs and projects. Safwco’s community organization development model has evolved out of seeking solutions to problems and issues like these, as a result of which many village organization in Sanghar District are working effectively and independently.

Safwco is a now making available these organizational development and capacity building packages for NGOs and CBOs based in rural areas of Pakistan especially in Sindh. The capacity building packages contain organizational development (OD) programs, mentoring, advisory services and networking faculties. OD series include organizational capacity assessment, assistance with training need analysis and training plan preparation, strategic planning and development of monitoring and evaluation framework.

Safwco is in a position to make the services available at marginal costs. For OD partner NGOs seeking capacity building packages will be offered training program in different areas.

Eligibility

Community leaders and organizations having extended at least one-two project on self help basis and with government, donor assistance are viewed as eligible for partnership. Interested organizations are requested to their expression of interests along with detailed profile of their respective organizations.

HID Network

From national point of view it is joint responsibility to develop the human resources in the country with the view to increase the organizational effectiveness and productivity. The organization in partnership with business and industrial organizations discharges the responsibility.
